Nomination Rules

1. Nomination forms shall be submitted to ABAA.
2. To be eligible to be an elected Board Director, an ABAA member must be in good standing upon application as well as during the term.
3. Nomination of candidates for election to the Board require:
 - a. the signature of at least three (3) ABAA members who are in good standing;
 - b. the written consent of the nominee; and
 - c. a current resume of the nominee.
4. To be eligible, ABAA must receive the completed and signed nomination form and resume of the nominee on or before the established deadline date either electronically or via regular mail.
