- The role of the Field Auditor is to perform quality assurance audits of air barrier assemblies on new commercial and institutional construction projects during installation. Inspect installation and review materials for compliance with specifications, ABAA requirements, and manufacturer requirements.
- Complete audit reports, document audits with photos, and address specific areas which have noted deficiencies and require corrective action(s).
