

Nomination Form for ABAA Fellowship

In accordance with the bylaws of the Air Barrier Association of America (ABAA), nominations for persons to be considered for ABAA Fellowship may be made by any voting member in good standing.

Fellowship is one of the most prestigious awards that ABAA gives and recognizes those that have worked tirelessly for the association and taken a leadership role and who consistently exceed expectations. Their advancement of the industry would be well known and recognized by their peers.

The bylaws outline the qualifications for those to be nominated. These are primarily the following:

- Any person representing a voting member of ABAA may be advanced to Fellowship if he or she has been a voting member of ABAA for not less than ten years at the time of nomination.
- The ABAA nominee shall be in good standing at the time of the nomination and review. The person shall have **notably contributed** to the advancement of the Air Barrier Association of America to be nominated for Fellowship.

A person cannot nominate oneself, however each nomination must be made by a voting member in good standing and the nomination cannot consist of more than one individual per Member Company.

The ABAA office requires a nomination form, signed by the nominator along with three (3) additional nominators who are ABAA voting members in good standing. **That is a total of four (4) separate signatures.** Each nominator must be from a separate ABAA member company and cannot include representatives of the nominee's company.

The nomination process requires written support as indicated below for the candidate's nomination be provided by each of the members who have signed the nomination form. Please note that all four (4) nominators must fill out questions 3 and 4 in the below nomination form. Only one completed form is to be submitted.

Thank you in advance for taking an active role in this year's nomination process. Your nomination will be provided to the Jury of Fellows.
